
7.1. Committee Reports

Board Effectiveness Committee

Jade Kent reported on the board renewal and that the committee has decided to go forward with the renewal in May with the date to be finalized. Kevin confirmed that Glen Feltham agreed be our guest speaker.

7.2. Executive Limitations

As per BP 3 – Monitoring Presidential Performance, the President and CEO must report on the Executive Limitations on an annual basis. To accomplish this requirement a schedule has been set up. For the month of March the following Executive Limitations were reported on: EL13 General Academic Council; EL14 Strategic Planning; EL15 Naming of College Facilities; EL16 Operation of the Medicine Hat College Foundation. Each report covered interpretation, compliance and evidence for that policy. It was noted that no record was found for *Naming of College Facilities* whereby the guideline was approved by the board for

On March 26 & 27 staff from Northern Lakes College will be at Brooks campus to provide demonstrations and training on program delivery. Our new VP Academic, Dr. Vicky Roy will be starting on April 20, 2020. Academic restructuring has been put on hold and will start up again once Vicky is settled. HWAE project dates have been updated with construction beginning in July 2020.

"BE IT RESOLVED THAT the Board of Governors of Medicine Hat College approves the offering of an Agroecology Technician diploma at Medicine Hat College."


