1. OBJECTIVE

This policy provides guidance to align with the applicable legislation and regulations regarding canine care in educational programs.

2. SCOPE

This policy applies to employees, students, and contractors, who are engaged in the use of live canines for educational purposes.

3. DEFINITIONS

- **Canine User:** anyone handling a canine for the program including employees, students, and contractors.
- Medicine Hat College Animal Care Committee (MHCACC): MHC's institutional • animal care committee (MHCACC).

4. PRINCIPLES

- 4.1 Medicine Hat College (MHC) recognizes the importance of animal care and protection and strives to align with related Federal and Provincial legislation and regulations.
- 4.2 MHC acknowledges that canines play an essential role in the educational environment.
- 4.3 MHC instills instructors, contractors, and students with its moral and ethical obligation to ensure exemplary care and use of live canines under its care.

5. DIRECTIVES

- 5.1 MHC has implemented measures in the operation of its facilities and programs to protect live canines and contribute to the quality of maintaining humane practices in the handling and treatment of all canines used for educational purposes.
- 5.2 The MHCACC assists departments and/or the instructional programs to comply with the canine care regulations.

- 5.3 All protocols involving the use of live canines intended for teaching are submitted for review to the Dean of Business and Continuing Studies.
- 5.4 The Vice-President, Academic has broad oversight for the development, administration, and maintenance of protocols to ensure exemplary care and use of live canines under the institution's care.
- 5.5 The unique character and potential risks to canines used by each department and/or program of the institution will be reviewed and evaluated.
- 5.6 MHC considers the improper treatment of canines in education to be a serious offence subject to severe penalties, up to and including disciplinary action.

6. **RESPONSIBILITIES**

- 6.1 The Dean, Business and Continuing Studies is responsible for:
 - (a) supervising the program to ensure appropriate application of the policy;
 - (b) ensuring qualified faculty and staff are hired; and
 - (c) managing the contractual relationships with suppliers of canines for the program and students.
- 6.2 **Students** are responsible for complying with the student requirements including the student contract and handbook.
- 6.3 **Instructors** are responsible for
 - (a) teaching the curriculum for the program; and
 - (b) reporting infractions to the immediate supervisor, Dean of Business and Continuing Studies, and the Vice-President, Academic.
- 6.4 **The MHCACC** is responsible for providing guidance on all aspects of canine care and wellbeing.
- 6.5 Contractors are responsible for complying with their contractual obligations.
